Well, folks, the season has come to an end and for the second time in the three-year history of the Rotisserie League, **Carlos** has prevailed. After a brief challenge, Carlos surged back into the lead and held on for the final month for the Championship.

Mike struggled early and was in sixth place as late as December but finished strong with the addition of some veteran players during the season. He mortgaged the future and will be looking to rebuild for 1990-91.

Bruce had a remarkable season, finishing third with a team of players passed over in the Auction Draft. With a large collection of inexpensive talent and many prime Free Agents available for selection in next fall's Draft, Bruce looks to be an early favourite for next season's title.


Wes had a disappointing season in which his goaltending, which was ranked number one last season, fell to sixth this year due to injury to Mike Vernon and the Rangers' handling of John Vanbiesbrouck.

Chris finished in fifth place, below .500, in the same position the team's prior owner, Grant, led them to last year. Chris will also be looking to rebuild, starting on the blueline.

Kelly had the misfortune of drafting too many players who were unable to excel on the power-play. A better balance will see him improve next season. Goaltending was a surprising weak spot as well.

Doug iced a team which was essentially weak in all areas. Strangely, his team was worst in goal-scoring overall, but 40% of the goals his team did score were on the power-play. His team's performance in this category provided nearly 75% of his team's points.

Below is the final Power Ratings Chart for each month of the season for each of the seven teams.



Bruce's team appears to be strongest heading into next year. His transactions during the season will result in his carrying a charge of 436 into next season, as the value of his post-Draft transactions exceeded the League average by that amount.

Mike hopes to hear from everyone as to whether you will have a team in next year's Rotisserie League. Remember to ask any hockey fans you know who may want to participate in League like this, with low stakes and regular updates. The League will work better with more teams involved as the players on the teams will reflect a more realistic cross-section of talent. As shown on the Miscellaneous Breakdowns page, the "average" player in the League is a star player. More teams in our League will result in owners having to make decisions with more risk involved, adding to the challenge.


